

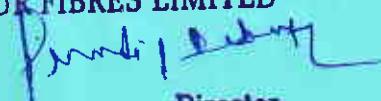

MEMORANDUM OF ASSOCIATION**

OF

YAJUR FIBRES LIMITED

- I. The name of the Company is **YAJUR FIBRES LIMITED**
- II. The Registered Office of the Company will be situated in the State of West Bengal.
- III. A. The main object to be pursued by the Company on its incorporation are :
 1. To carry on the business of cotton spinners, and doublers, flax hemp and jute spinners, linen manufacturers, flax, hemp, jute and wool manufacturers, wool combers, worsted spinners, yarn merchants, bleachers and dyers, printers and makers of vitriol, bleaching and dyeing materials and to comb, prepare, spin, dye and deal in flax, hemp, jute, wool, cotton, silk and other fibrous substances and all blending thereof or otherwise manufacture, buy and sell and deal in fabrics whether textile, felted, nettled or looped.
 2. To carry on the business as manufacturers, processors, producers, assemblers, spinners, weavers, twiners, bleachers, exporters, importers, shippers, agents, representatives, traders, dealers, stockiest, distributors and otherwise deals in jute and jute goods including jute mattings, jute carpets, jute yarn, jute twining, jute wool, cotton and other textiles, cotton, yarn and cotton products, wool wool yarn and woolen goods, handicrafts, piece of arts, beautification materials made in jute, wool and cotton, polypropylene, polyethylene, coir and other natural and synthetic fibres or strips or materials.

B. Matters which are necessary for furtherance of the objects specified in clause III(A):

1. To carry on the business of manufacturing, buying, selling, importing, exporting and dealing in cotton, silk, art silk, rayon, nylon, synthetic fibers, staple fibers, polyester, worsted, wool, hemp and other fibre materials, yarn, cloth, linen, rayon and other goods or merchandise whether textile felted, netted or looped.
2. To acquire and take on lease all or any of the fixed assets, machinery, furniture, fixture, stores, stock of raw and finished materials, rights, privileges, etc. appertaining to business or any other factory to achieve the main objects of the Company.
3. To repair, alter remodel clean, renovate, convert manipulate and prepare for re-sale of any goods from time to time belonging to the Company.
4. To buy the purposes of the Company drums, barrels, packages, tanks and containers tubes, aerosol containers of every description from steel, tin and other metals and of such substances like wood, paper board, plastics as may furnish materials for such manufacturing in any of its branches.
5. To lend money either with or without security, and generally to such persons and upon such terms and conditions as the Company may think fit and also to invest the money of the Company not immediately required in such manner as from time to time may be determined, provided that the Company shall not carry on the business of banking as provided in the Banking Regulation Act, 1949.
6. To manufacture, import, export, buy, sell, exchange, alter, improve, manipulate, prepare for market and otherwise deal in all kinds of plant, machinery, apparatus, tools, substances, materials and things, necessary or convenient for carrying on any of the above specified business or proceedings, usually dealt in by persons engaged in the like business.
7. To guarantee the performance of any contract or obligations and the payment of money or dividends and interest on any stock, shares or securities of any company, corporation, firm or person in any case in which such guarantee may be considered directly or indirectly to further the main objects of the Company.
8. To sell, improved, manage, work develop issue mortgage charge hypothecate deposit, by way of loan or otherwise dispose of turn to account of otherwise deal with all or any part of the property of the company whenever or however require.
9. To establish branches, showrooms, offices, shops, factories, in different parts of the country and provide for their administration by local office.
10. Subject to the provisions of the Act to amalgamate with any Company or Companies having objects altogether or in part similar to those of this Company.
11. To adopt such means of making known to the public the business of the Company as may seem expedient and in particular by advertising in the press, by circulars and by publication of books and periodicals.
12. To distribute any of the property of the Company in pieces among the members but no distribution amounting to a reduction in capital shall be made without the sanction, if any, for time being required by law.
13. To do all or any of the above things as principals, agents, contractors trustee or otherwise and by or through trustee, agents or otherwise and either alone or in Company with others and to establish agencies or branches for purpose of the Company's business in such places as may be considered necessary.
14. To borrow or raise or secure the payment of money in such manner as the company may think fit and in particular by the issue of bonds, debentures and debentures stock perpetual or otherwise, charged upon all or any part of the Company's property, both present and future, including its uncalled capital and to purchase, release or pay off any such securities.

15. To enter into partnership or into arrangement for sharing the profits venture with any persons, Firms or Company carrying on or about to carry on any business which the company is authorized to carry on or any business capable or being conducted so as directly or indirectly to benefit this company and to acquire of joint in acquiring any such business.
16. To sell or dispose of the undertaking of the Company or any part thereof for such consideration as the company may think fit and in particulars for shares fully or partly paid debentures, debenture-stock (redeemable or perpetual) or securities, of any other company having objects altogether or in part similar to those of the company, and to distribute any such share, debentures, debenture-stock or securities amongst the members of this company and either by way of dividends or upon any return of capital.
17. To promote any other company for the purpose of acquiring all or any of the property and liabilities of this company or for any other purpose which may seem directly or indirectly calculated benefit this company, and to pay the costs charges and expenses, preliminary and incidental to the promoters, formation, establishment, regulation and advertising of any such company. Generally to do and perform all such acts and things as may for the time being be conducive or incidental to the attainment of above objects.
18. To apply for promote and obtain under any act or parliament, charter, privilege, concession, license or authorization of any Government, State of Municipality, Provisional Order or License from any authority for enabling the company or any effecting any modification of the constitution of the Company or for any other purpose which may seem calculated directly or indirectly to prejudice the interests of the Company.
19. To apply for Purchase or otherwise acquire and project, prolong and renew in any part of the world, any patents, patents rights, trade mark, designs, licenses, protections, concessions and the conferring of any exclusive or non exclusive or limited rights to their use of any secret or other information as to any invention, process or privilege which may seem capable for being used for any of the purpose of the company or the acquisition of which may seem calculated directly or indirectly to benefit the company and to use, exercise, develop, grant licences or privileges in respect of or otherwise turn to account the property, rights and information acquired.
20. To manage, land, building and other properties whether belonging to the company or not, and collect rents and Income, and to supply tenants and occupiers and others refreshments, attendance, light writing rooms, reading rooms, meeting rooms, electric convenience and other advantages.
21. 28. To do all and everything necessary, suitable or proper for the accomplishment of any of the purposes or the attainment of any of the objects or the furtherance of any of the powers hereinbefore set forth.
29. To carry on net marketing, advertising through websites, promotional activities, channel establishments for its various products and services, providing secured payment processing, net commerce solutions for business to business, business to C011SLIMer.
30. To carry on the business of manufacture and otherwise deal in packing, packing requisites made of polythene and synthetic material, cartons made of card board, wood, glass or other material, rubber, metal, glass or plastic containers as also containers of any other material or substances.
31. 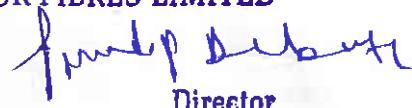

V. The Authorised Share Capital of the Company is Rs. 25,00,00,000 (Rupees Twenty Five Crores only) divided into 2,50,00,000 (Two Crore Fifty Lakhsonly) Equity Shares of Rs.10/- with such rights, privileges and conditions attaching thereto as are provided by the regulations of the Company for the time being, with power to increase and decrease the capital into the Company and to divide the shares in capital for the time being into several classes and to attach thereto respectively such preferential rights, privileges or conditions as may be determined by or in accordance with the Articles of the Company for the time being and to modify or abrogate any such rights, privileges or conditions in such manner as may be permitted by the Act or provided by the Articles of the Company for the time being.
